A MESSAGE FROM THE

EXECUTIVE DIRECTOR



IDIS started with a goal to protect the future water source of Davao City from expanding agribusiness in the upland watersheds. One watershed, one city. Since then, we covered the largest highly urbanized city in the Philippines, recognizing that initiatives in the upland rural areas are interlinked to the urban lowland and coastal areas. In our 20th year this 2019, we are now working in multiple cities and municipalities in South Central Mindanao continuing our advocacy --- clean water, healthy watersheds.

IDIS started with a goal to protect the future water source of Davao City from expanding agribusiness in the upland watersheds. One watershed, one city. Since then, we covered the largest highly urbanized city in the Philippines, recognizing that initiatives in the upland rural areas are interlinked to the urban lowland and coastal areas. In our 20th year this 2019, we are now working in multiple cities and municipalities in South Central Mindanao continuing our advocacy --- clean water, healthy watersheds.

The reason for the expansion was only natural, given that ecological services and the effects of their destruction cut across political boundaries. The initiatives we started and sustained over the years are slowly being adopted and institutionalized in the Local Government. For instance, the Lunhaw Awards, initiated by IDIS with DACS, DCWD, CAO and CENRO in 2012 is now being handled by the City Environment and Natural Resources Office as the official secretariat head by virtue of an Executive Order issued by the City Mayor. Our community-based forest guards (Bantay Bukid volunteers) have not only been recognized but are now regularly supported by the LGU through the PSSCC. We aim that similar efforts will also be adopted by other cities and municipalities in South-Central Mindanao.

2019 was also the year the climate crisis finally reached the center of political agenda in developed nations, thanks to the inspiring school strikes led by children. In response, we continue our due diligence in reducing the risks in the way we develop our cities and think of our communities long-term, with climate change in mind. We have mapped the remaining green zones in the city and conducted research on the effects of quarry to our riparian ecosystem and communities. We will push for corresponding actions to protect our rivers, remaining wetlands and urban forests that serve as crucial carbon sinks. We will continue to advocate for the banning of single use plastic and the long-term changing of mindset towards reducing waste at source. The planned waste incinerator facility, posed as the band-aid solution to unmanageable waste of urbanization, will produce various environmental and health damages which will be further aggravated with urban heat.

On a personal note, this year I gave birth to Eko. One doesn't need to have a child to understand the need to think about the future generations, the natural resources left for them and the state of the planet they will have to live in. But all we have been advocating for becomes crystal clear whenever I see Fko.

Now, I am more inspired and determined to continue working for a better and livable future for him and the future generations.

We continue to extend our sincere appreciation to our funding partners for their continued trust and confidence in our work. We thank DKA Austria and Misereor Germany for their support in our project, " Scaling-up Watershed Management in South-Central Mindanao" from 2017-2019 as well as for their commitment to support our next project cycle. We also thank the

Alternative Law Group for their support in our watershed intervention case; the City Government of Davao for their financial support to the Lunhaw Awards and Bantay Bukid Program; and to IDEALS, Inc. for partnering with us in implementing their project in Compostela Valley.

IDIS now has 20 years worth of knowledge and experience in doing watershed policy advocacy. But there will be many challenges still --- some new and some old persisting ones; both external with our government, CSOs and funding agency partners, as well as internal within our organization. As we have learned from two decades of watershed management work, we have to bounce back. Resilience is key if we are to ever achieve clean water, healthy watersheds for all. Padayon!

The study recommends:

- ✓ Pass an ordinance to protect the 10 remaining wetlands and 20 urban forests that serve as habitat for endemic wildlife, perform ecological services and serve as city's tourism spots for biodiversity.
- Pass a policy to protect streetscapes such as street islands, rotundas, and linear parks that serve as important green spaces from demolition or damage due to infrastructure projects.
- ✓ Integrate green zones in the Comprehensive Land Use Plan and Zoning Ordinance.
- ✓ Explore negotiations with private owners who are willing to sell their lands to secure more urban nature reserves and provide incentives to those who are willing to lease their lands as privatelyowned publicly open spaces (POPOS)
- Mainstream Adopt-a-Park program for reforestation or greening of those green spaces with poor to moderate vegetative cover to be led by CENRO in partnership with the BLGUs and the private sector.



Davao City celebrated its first Lunhaw Month, declared by virtue of Executive Order No. 28 series of 2018 to boost promotion of the Lunhaw Awards, Davao City's annual search to recognize and promote environment-friendly initiatives. It is also the first time that the City Environment and Natural Resources Office (CENRO) chaired the Lunhaw Committee secretariat and led the conduct of the event.

The Lunhaw Network composed of past awardees and finalists continue to grow now with over 90 members. Through Lunhaw Conversations, these green advocates and practitioners continue to meet even after the awarding ceremony where they exchange learnings and experiences in organic farming, education and advocacy, green living. In this process, awardees and finalists expand their network for opportunities and promotion of their products and advocacies.

GREEN PRACTICE IN FOCUS

The Fight against Single-Use Plastics



In Davao City, as of 2018, an approximate number of 1012.486 tons of waste produced per day. Davao City's waste generation continues to rise with the increase in population, improvement of living standards and economic growth especially within the urban areas. According to the City Environment and Natural Resources Office (CENRO) the waste generated per day from 2017 (990.703 tons) has increased by 2.2% in 2018 or having 1012.486 tons on a daily basis.

Accordingly, disposed waste is dominated biodegradable waste with 50 percent, followed by residuals which accounts for 29 percent, recyclable at 19

percent and special waste at 2 percent. Residual waste are those rubbish that are not able to be reused, recycled or composted. Recycling and waste segregation continue to be a challenge despite the environmental campaigns of the CENRO and the rules and regulations as mandated in the Davao City Ecological Solid Waste Management Ordinance of 2009.

The issue on improper solid waste management and plastic pollution evolved from bad to worst. Over the past ten years, almost 57 marine animals found dead due to plastic ingestion along the coastline of Davao Region. Various efforts from private individuals, NGOs, academic institutions, and businesses were mainstreamed. promoted, and seen to help the City Government of Davao to solve this long overdue issue. This also further strengthens the organization's campaign to lobby for the passage of policy banning single-use plastic in Davao City and urge the LGU to fully implement the ESWM Ordinance.

IDIS is proactively engaging with the Office of Councilor Diosdado Mahipus Jr. in the drafting and in the preparation of the ordinance regulating Singleuse Plastics in Davao City. Alongside with this, IDIS also organized forums in partnership with government offices, academe, and CSOs to heighten the awareness of Davaoenos regarding Zero Waste Lifestyle and the current waste status of Davao City.

PARTNERSHIP IN FOCUS

The Youth's Role in Sustainability

The low interest and involvement of the youth in tackling environmental problems has been a recurring concern raised in the meetings of the Sustainable Davao Movement. University of Mindanao's Institute of Popular Opinion's Davao Youth Situationer in 2017 revealed that only 1.1 percent of students are affiliated with environmental groups. While the youth of today are often accused of being a "selfie" generation, uninvolved in social causes, the youth in Davao City has shown that this may be a faulty-generalization, with their efforts not always recognized and their potential underestimated.

IDIS' longest running initiative on community-based water monitoring relies on youth volunteers known as the Bantayo Aweg in Brgy. Tawantawan and recently the Sangguniang Kabataan in Baguio District and other schools from downtown have joined. In 2018, IDIS launched the SDG Research Symposium which gave young researchers opportunity to share proposed solutions to the city's environmental problems ranging from pollution in Davao river to crop loss in banana plantations.

In 2019, IDIS likewise conducted a series of environmental journalism trainings to over 75 students from 12 high schools in three districts. Outputs of the training consisting of environmental issues, story ideas and story plans revealed that students are aware and are directly affected by unresolved environmental issues, whether in their schools or in their communities. Issues

include health and environmental effects brought about by chemical spraying in plantations for those living in rural communities in the third district to cross-cutting concerns on improper waste management and climate change throughout the city.

More than 500 students joined the global climate strike last September 27, 2019 in the call for governments to take urgent action to address climate change by keeping our commitments to the Paris Agreement. Students' demands include: declaration of climate emergency in the Philippines, banning of single-use plastics, no to coal-fired power plants, no to waste-to-energy facility, and no to over-extraction of natural resources. The student climate strike was organized by the Students' Environmental Alliance of Davao composed of 11 schools with a goal of strengthening member schools' connection to the environment through dialogues, interventions and eco-friendly activities.



STRENGTHENING ORGANIZATIONAL RESILIENCE

IDIS consistently maintained its efficient use of resources given by its donors Misereor and DKA Austria with no negative findings in its external audits this year. The organization likewise complemented its human resources and trained the youth involved volunteerism and internships. This includes 2 forestry students from University of Mindanao (UM), 2 geology students from University of Southeastern Mindanao (USEP) and 2 graduate students from Ateneo de Davao University involved in IDIS research and advocacy activities.

Formal partnerships on various environmental advocacies were sealed through memorandum of agreements with several institutions including UM College of Architecture and Fine Arts, F. Bangoy National High School, Bambuhay, Koronadal City, VSO Philippines, Philippine Science High School SOCKSARGEN.

Competencies of IDIS staff are continuously updated through the latest trainings and learning exposures to other cities and countries, and grounded with direct community experience and engagement with government and CSO networks. They have been recognized and tapped as resource persons on various environmental-related talks.

Lemuel Manalo is a dedicated environmental planner who passionately aims for a climate-adaptive, disaster-resilient, transit-oriented, safe, and PWD-priority cities and human settlements in a healthy environment.

He's pursuing his Master of Science in Environment & Resource Management at the University of Southeastern Philippines where he gained expertise on land-use planning and Geographic Information System (GIS) mapping.

As IDIS ERS, he spearheads research projects on sustainable drainages and flood management, urban greenery and landscapes to combat heat island effect, city public parks and open spaces assessment with the New York University Marron Institute for Urban Management.

In April 2018, he presented IDIS study on Permeable Pavement System for Flood Mitigation at the 2018 Malaysia Flood Conference held in Berjaya Times Square, Kuala Lumpur, Malaysia. At the same year, the research was proposed and became the baseline of the recently passed City Ordinance on Mainstreaming Permeable Pavements for Building Developments in Davao City.

For his personal advocacy, Lem has the heart for persons with disability, especially on providing them safe streetwalks, accessible public facilities, and comfortable transportation. This lead him to creating his own social media hashtag #empowerPWD, regularly sharing PWD-friendly issues, initiatives and smart PWD-friendly designs and technologies.

Atty. Mark Penalver specializes in the practice of environmental law, dedicating his expertise in upholding environmental laws in Mindanao. He provides oversight and ensures that enabling watershed policies are crafted, lobbied, passed and strictly implemented. He represents the organization in local special bodies, validating compliance of businesses in conservation areas and monitoring strict policy implementation on the ground. He also provides policy recommendations to facilitate immediate resolution to reported environmental violations.

He was first exposed to advocacy work during his law school days when he had his internship with Sentro Alternatibong Lingap Panligal (SALIGAN). He and other law students were assigned in depressed areas affected by mining activities. It was during this internship that he was exposed to the realities of alarming environmental conditions. This awakened his passion to help protect the environment, particularly the right to clean and safe water.

In 2013, he was one of the law students from University of Mindanao to join the US Embassy-supported orientation seminar on legal aid program for Mindanao. The program was the US Embassy-Philippines flagship in Mindanao to encourage law schools to set up their own school-based legal aid clinic. It was through Mark's relentless efforts that the legal aid clinic of the University of Mindanao was set up - the University of Mindanao Legal Advocacy Network (ULAN). His leadership paved the way for ULAN to become a recipient of US Embassy Philippines' grant to roll out series of legal aid activities.
